Music Lessons

All music lessons will be charged at the rate sent out by the Visiting Instrumental Teacher, who will bill parents directly at these rates. No VAT is chargeable on music lessons taught by self-employed music teachers. It is the intention that an annual average of 30 lessons will be the norm. Any special arrangements, e.g. to coach for examinations, will be cleared with parents in advance.

There is no separate charge made by the School for ensemble playing.

For Choristers, the charge for tuition for 30 lessons for one instrument will be borne by St John's College.

REGISTRATION AND ENTRY FEES

A non-returnable Registration Fee of £60 (£50 +VAT) is payable. An Entry Fee of £600 (£500 +VAT) is payable on acceptance of a place in the School. This fee is returnable by offset against the final fee bill submitted when a pupil leaves at Form 6. It is non-returnable if a place is offered and not taken up or if a child leaves before Form 6.

NOTICE: A term's notice, in writing, is required for any change to optional extras or to remove a child from the School, otherwise one term's fees are due to the School in lieu of such notice.

<u>IMPORTANT: PLEASE NOTE THAT ALL FEES ARE DUE ON OR BEFORE THE FIRST DAY OF TERM.</u> Failure to settle the account by <u>the first day of term</u> will incur a late payment administration charge of £50 per week.
